External evaluation

External Evaluator

- An external evaluator were appointed by the Consortium to test and evaluate Intellectual Output 1 and Intellectual Output 2.
- The external evaluator's role in this instance is to bring new, objective and unbiased insights to the evaluation process.
- On completion of the evaluation work the external evaluator produced a report suggesting modifications and recommendations.

Testing and Improving

Phase 1

- Taking EQAVET principles into account, the partners evaluated and improve the training platform developed in house. Improvisations have been made. Led by LMA with support from Maritime Innovators

Testing and Improving

Phase 2

- There will be an evaluation by 3 piloting groups after the improvements have taken place. 3 piloting groups were formed with at least 8 seafarers/end-users from the 3 different countries (Turkey, Lithuania, Romania) with an experienced teacher. This initial pilot group was in English. A teacher lead the group and verified their knowledge and fill their knowledge gaps.
- All students including the teacher filled in a questionnaire. All questionnaires were summarised into one report. The course were enhanced after the improvement report, which were based on the comments of the testing groups.
- The final version in English were available to public. Marine Innovators with support from LAM France

Testing and Improving

Phase 3

- All translated PraC-MARENG platform were evaluated by 5 piloting groups in 5 partner countries in their language. All seafarers /end users will perform self-learning using SMCP Based Maritime English Training Tool and a teacher verified their learning and awareness.
- All end users filled a detailed questionnaire. The teacher also filled a special questionnaire.
- All questionnaires were summarised in one report. The PraC-MARENG Platform were improved after the piloting group reports). The final version of the course were available in the 23rd month of the project and the platform were open to the public.
